WHERE & WHEN: Expressway Park, Milford, Ohio - August 26-27. Lower E and Upper C/ D divisions.

ENTRY FEE & FORMS: The entry fee for this double elimination event will be two hundred twenty five (\$225.00) dollars. Call the park and pay fee by credit card or drop fee off at the park.

It is the manager's responsibility to submit a roster that adheres to the guidelines below!

UPPER C/ D DIVISION: Mixed teams that play in the Upper C/ D Division may not have male players who competed during the season on any association Men's B teams or higher or any women that appear on the RPL. Three home runs per gender. (inning ending out).

LOWER E DIVISION: Mixed teams that play in the Lower E Division may not have male players who competed during the season on any association Men's Class D teams or higher or any female players that competed on any association C teams. Lower E teams are not permitted any home runs (inning ending out).

AWARDS: Team awards will include first through third place; individual awards for 1st and 2nd place (15) Most Valuable Player by gender, Outstanding Defensive Player per gender, and All-State Tournament Team plaques (10) All awards are based on 12 teams per division and will be pro-rated with less than 12.

BERTHS AND TRAVEL: A paid berth to the WSL World Tournament or \$375 Travel expense will be awarded to each First Place team. If there are fewer than 12 team per division, the paid berth will be pro-rated.

PLAYING RULES: Official WSL Mixed Team Rules with the exception of eligibility rules will be in effect.

PROTESTS: There will be a \$25 protest fee on playing rules; however, protests must be lodged before the next pitch. Eligibility protests are \$200 and must be done before the last out of the game.

GAME TIMES: The tournament will begin on Saturday morning at 8 AM, and all teams are expected to be available for play at that time. Brackets will be posted online at www.expresswaypark.com by noon on Thursday.

FIELD/WEATHER CONDITION INFORMATION: For field or weather condition information in case of inclement weather during the tournament, call Expressway Park's game status hotline at 513-786-6964.

DAILY GATE ADMISSION POLICY: A \$3.00 admission fee will be charged on Saturday and Sunday to EVERYONE except senior citizens 62 and over and children under 16 accompanied by an adult. Admission is non-refundable.

FOOD & DRINK: Ohio State Law prohibits bringing any food or drink onto park property, including the parking lot. This includes coolers. Tailgating with alcohol is NOT permitted in the parking lot. Teams doing so will be ejected from the tournament. **WARNING:** The park is patrolled regularly by the Milford Police and violators will be cited. Thank you.
